What are cookies?

Navigation cookies

- a) updating, rectification or, when interested, integration of data;

b) cancellation, transformation into anonymous form or blocking of data processed unlawfully, including data whose retention is unnecessary for the purposes for which the data were collected or subsequently processed;

c) confirmation that the operations in letters a) and b) have been notified, also as regards their content, to those to whom the data were communicated or disseminated, unless where this proves impossible or involves a manifestly disproportionate to the protected right.

- 4. User has the right to object, in whole or in part:
- a) for legitimate reasons the processing of personal data, pertinent for collection purposes;

b) for legitimate reasons the processing of personal data, pertinent for collection purposes.
